 2.2. GREEN PALM FARMERS ACTS AS A FACILITATOR, CONNECTING MEMBERS WITH FINANCIAL INSTITUTIONS FOR ACCESS TO:

 - MARKETS AND SUPPLY CHAIN OPPORTUNITIES

3. DISOUALIFICATION AND WITHDRAWAL

- 3.1. A MEMBER MAY BE DISQUALIFIED FOR
- INSUBORDINATION
 DISRESPECT OR VIOLATION OF ESTABLISHED PRINCIPLES
- OI DISQUALIFICATION OF VOLUNTARY WITHDRAWAL, THE MEMBER MUST:
 RETURN THE CERTIFICATE OF MEMBERSHIP TO THE STATE COORDINATOR
- CEASE TO REPRESENT THEMSELVES AS A GREEN PALM FARMERS MEMBER
 3.3. NO REFUND OF ANY KIND SHALL BE GRANTED UPON WITHDRAWAL OR REMOVAL
 - FROM THE INITIATIVE.

4. VOLUNTEER APPOINTMENTS

- 4.1. ACTIVE MEMBERS MAY BE APPOINTED AS STATE OR LOCAL GOVERNMENT COORDINATORS.
 4.2. COORDINATORS ARE APPOINTED TO OVERSEE PROJECT EXECUTION AND SUPPORT LOCAL
- OPERATIONS UNDER THE DIRECTIVE OF THE NATIONAL COORDINATOR.
 4.3. COORDINATORS ARE NOT AUTHORIZED TO INDEPENDENTLY DIRECT OR CONTROL MEMBERS' PERSONAL ACTIVITIES.
 - 4.4. APPOINTED COORDINATORS SHALL RECEIVE A CERTIFICATE OF ENGAGEMENT, VALID FOR ONE (1) YEAR AND RENEWABLE AT THE DISCRETION OF THE NATIONAL COORDINATOR.

5. LOAN FACILITATION

- 5.1. MEMBERS SEEKING LOANS MUST MEET ELIGIBILITY REQUIREMENTS SET BY THE PARTNERING FINANCIAL INSTITUTIONS.
- 5.2. MEMBERS FOUND INELIGIBLE FOR SUCH PROGRAMS WILL BE DISQUALIFIED FROM THE LOAN **FACILITATION PROCESS.**
- 5.3. CREEN PALM FARMERS DOES NOT PROVIDE COLLATERAL FOR ANY MEMBER BUT WILL SUPPORT THE PROCESS THROUGH GUIDANCE AND FACILITATION.
